Memorandum of Understanding

The Memorandum of Understanding (MOU) is between the ASSOCIATION, United Providers of Mental Health (UPMH) and the MEMBER,

listed as an INDIVIDUAL / ORGANIZATION (circle one) member.

Program Statement and Parties to the Memorandum of Understanding (MOU)

1. United Providers of Mental Health (UPMH), the ASSOCIATION, is a not-for-profit membership association in Southern Nevada founded by providers for providers of mental health and wellness.
2. The mission of UPMH is to SUPPORT each other by providing a platform for concerns to be heard and solutions to be created, to EDUCATE through specialized training and presentation of resources and materials, and ADVOCATE for one another by providing a sound credentialing and certification process in order to strengthen our members' viability as a mental health and wellness provider. Our motto: Together We Can Overcome.
3. The MEMBER must have an understanding and agreement to the mission of UPMH.

Purpose

1. The purpose of this MOU is to create the framework for cooperation that will enable the ASSOCIATION and the MEMBER to benefit from common activities and respective strategies as relevant to the association mission. This will further mutual understanding, and, where areas of joint interest have been identified, close coordination between the ASSOCIATION, the MEMBER, and between MEMBERS.

Cooperation to MOU

1. The MEMBER agrees to work with the ASSOCIATION in its efforts to Support, Educate, and Advocate and improve health and wellness of the populations that are served by the providers within the ASSOCIATION.
2. The MEMBER must attend at least 75% of the monthly association meeting and/or activities.
3. The MEMBER must raise awareness to the cause and mission of the ASSOCIATION.
4. The MEMBER, as a provider of service, must practice within ethical standards and within the scope of practice, as representative of quality and viability which is encouraged by the ASSOCIATION of its members.

5. The ASSOCIATION agrees to share information and data obtained through the implementation of projects, as well as lessons learned, with Association Members.
6. The ASSOCIATION will participate in partnership meetings and events when possible.
7. The ASSOCIATION will raise awareness and support community members.
8. The ASSOCIATION will take action on items agreed on by the association members
9. The ASSOCIATION will operate with integrity.
10. The ASSOCIATION will provide fair and equal representation to all its members.

This Memorandum of Understanding is effective upon signature. It is understood by all parties that either party can cancel this agreement for any violation to the agreement, by written notification.
